RESOLUTION OF THE GOVERNING BOARD OF THE
REDEVELOPMENT AGENCY OF SALT LAKE COUNTY
AUTHORIZING THE PURCHASE OF A PARCEL OF LAND

R E C I T A L S

WHEREAS, Autonomy, Inc. (the “Owner”) owns two parcels of real property located at 9021 West Magna Main Street, Magna, Utah, identified as Parcel Nos. 14-30-209-026-0000 and 14-30-209-027-0000 (collectively the “Property”); and

WHEREAS, the Redevelopment Agency of Salt Lake County (the “RDA”) desires to purchase the Property for \$50,000; and

WHEREAS, the terms and conditions for the acquisition of the Property are contained in the Real Estate Purchase Contract (“Purchase Agreement”), attached hereto as Exhibit “A”; and

WHEREAS, it has been determined that the best interests of the RDA will be served by paying the Owner \$50,000 for the Property under the terms and conditions of the attached Purchase Agreement. The execution of the Purchase Agreement will be in compliance with all applicable state statutes and county ordinances.

R E S O L U T I O N

NOW THEREFORE, IT IS HEREBY RESOLVED by the Governing Board of the Redevelopment Agency of Salt Lake County that the attached Purchase Agreement is accepted and approved, and the Board authorizes the RDA’s Executive Director to execute the Purchase Agreement and to perform all other actions and sign all other documents reasonable necessary to comply with the RDA’s obligations contained in that document and close the purchase on behalf of the RDA.
