Mr. Brad Neff, Tax Administrator, explained the historical practice of accepting late appeals under the category of extraordinary and unanticipated circumstances when taxpayers appeal the value of properties they purchased after the Notice of Valuation is mailed in July. He stated that the Board historically allowed these appeals to proceed because the new owners did not receive actual notice of the assessed value. He recommended that the Board continue to accept these late appeals.

Board Member Granato clarified that this issue occurs between July and November when a property is purchased and the new owner is unaware of both the value and the appeal deadline. Mr Neff confirmed that was correct.
