Pledge of Allegiance

Council Member Bradshaw led the Pledge of Allegiance to the Flag of the United States of America.

2. PUBLIC COMMENT

Mr. Steve Van Maren stated he attended two of the four meetings of the Housing Trust Fund Committee and thought the committee was well prepared and had good arguments.

3. REPORT OF ELECTED OFFICIALS:**3.1. County Council Members**

Council Member Theodore stated she went to a sandbagging event over the weekend for which the County and the community filled bags. It was fun, but hot and labor intensive. She complimented the employees who were there working long hours, as they also go out and check the water levels late at night. She suggested providing coverage and water for them because they get tired, hot, and sunburned.

Council Member Stringham stated the Greater Salt Lake Municipal Services District (MSD) held a meeting last week where it discussed projects. The MSD is starting to ramp up for the project season.

Council Member Winder Newton stated the Intergenerational Poverty Task Force meeting was held last week, where it discussed the upward mobility program that the Department of Workforce Services is putting forward. Some non-profit

organizations are on that task force and can pass along that information. The Intergenerational Poverty Task Force also talked about legislation that passed during the legislative session related to families experiencing intergenerational poverty.

3.2. County Mayor

Mayor Jennifer Wilson expanded on the flood control emergency stating the command structure meets twice a week, on Wednesdays and Fridays, to work through all the one-offs. A lot is going on in Emigration Canyon, so the County is working with the community there. It was a Herculean effort to make sure Ruth's Diner stayed open. The Emigration Metro Township mayor will be out watching the water levels again tonight. The County also just learned of a substantial mudslide up Little Cottonwood Canyon. No property was directly impacted nor was anyone injured, but the County will continue to monitor that. She thanked the Council for approving a budget adjustment in the Council Work Session to allocate funding for flood control efforts.

Ms. Catherine Kanter, Deputy Mayor of Regional Operations, stated she was also grateful to the Council for appropriating the money needed to continue fighting this flood emergency.

A motion was made by Council Member Harrison, seconded by Council Member Bradshaw, to open the public hearing. The motion carried by a unanimous vote.

The following citizens spoke in favor of the formation of the Salt Lake County Conventions and Tourism Assessment Area (CTAA) for the following reasons:

Visit Salt Lake's Board of Directors analyzed this for two years before going to the Legislature asking it to allow this, and it endorses this unanimously; the CTAA will help the tourism industry rise to a higher standard for the benefit of thousands who depend on tourism to pay bills and raise children; it will support 48,000 jobs; it will give the hospitality industry another tool to bolster the economy; it presents an opportunity to bring fresh money into the community; the hospitality industry is just rebounding from the pandemic, and the assessment is a way to garner more business; most tier one convention cities trying to be competitive have an assessment in place or are pursuing one, and those that have a tourism assessment have seen a positive impact in obtaining new business; it is an opportunity to be competitive with other markets; it will bring new tourism to Salt Lake County for the hotels, which have a commitment to their employees to keep their rooms full and give them a safe and secure working environment; the hospitality industry brings people together, and hotels host various groups that would not otherwise come to Salt Lake; convention attendants and tourist visitors are high spenders in Salt Lake County, and high-speed visitors supercharge the economy, as they spend money at shops, restaurants, and bars, and they are tenants in commercial properties; there is a ripple effect on the economy when tourists spend money, as conventions and trade shows hire local trade persons, and those trade persons then spend into the economy again; tourism is vital for the success of the City Creek Center, as visitor spending can be as much as 40-60

percent of its business; tourism is an enormous economic engine with \$4.62 billion in annual visitor spending, resulting in \$215 million in local tax revenue for Salt Lake County; data sources indicate 32 percent of total direct spend in the County is from visitors, which is essential to foster downtown and restaurants, providing opportunities for businesses of all types, including small independently-owned businesses; Visit Salt Lake has done a terrific job growing tourism, but there is more room to grow, as Utah is poised for growth; the CTAA is the best way to bolster Visit Salt Lake's budget, which is funded exclusively from a portion of Transient Room Tax; Visit Salt Lake is underfunded compared to its peers and at a competitive disadvantage as it competes for tourism, and the CTAA will go a long way in closing that gap, and it will pay big dividends for the County; and Visit Salt Lake's leadership can be trusted to shepherd these funds through the process and it has the ability to steward this destination as this tourism revenue increases because it is a forward-looking, progressive destination management organization and its approach is commensurate with best practices across the nation.

Mr. Steve Van Maren stated in his research, he could not see a limit on the amount a hotel could charge for this assessment and who would pay it. He suggested having visitors pay 1 percent and the property pay the other 1 percent, as the properties are going to gain from this. They should have a financial position in this, rather than just an administrative effort.

Mayor Jennifer Wilson stated she was on Visit Salt Lake's Board of Directors, and was involved with a lot of the revenue analysis, looking for windows of opportunity, and

engagement around the challenges the industry faced during Covid. This is a situation where the business community asked for this assessment to help them. Having rooms filled will also help Salt Lake County be competitive and expand its revenue base. She supported this and encouraged the Council to support it.

A motion was made by Council Member Bradshaw, seconded by Council Member Harrison, to close the public hearing. The motion carried by a unanimous vote.

Council Member Bradshaw stated the next step in this process is for the impacted municipalities and different assessment areas to review it, and then bring it back to the Council for a final decision. The Council will not take action today; it will vote on this June 6, 2023.

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL AUTHORIZING EXECUTION AND DELIVERY OF A REAL ESTATE PURCHASE CONTRACT WITH THE UTAH DEPARTMENT OF TRANSPORTATION AND APPROVING CONVEYANCE OF A PARCEL OF REAL PROPERTY AND A TEMPORARY CONSTRUCTION EASEMENT

RECITALS

A. Salt Lake County (the “County”) owns a certain real property located at approximately 2100 South State Street, Salt Lake City, Utah, also identified as Parcel No. 16-18-355-002-2000 (the “Property”).

B. The Utah Department of Transportation (“UDOT”) is constructing roadway improvements along State Street in Salt Lake City (the “Project”) and would like to acquire a 6-square-foot portion of the Property (the “Parcel”) from the County and a temporary construction easement as part of the Project.

C. UDOT has submitted a Real Estate Purchase Contract (the “REPC”) to the County for the acquisition of (1) the Parcel via a quit claim deed (the “Deed”) and (2) the temporary construction easement via a separate document (the “Easement”).

D. The total amount offered by UDOT for acquisition of the Parcel and the Easement is \$2,000.00, which amount has been reviewed and approved by the Salt Lake County Real Estate Section as full and adequate consideration.

E. It has been determined that the best interests of County and the general public will be served by executing the REPC, the Deed, and the Easement attached to this Resolution. These actions will be in compliance with all applicable state statutes and county ordinances.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the grant and conveyance of the Parcel and the Easement to UDOT pursuant to the REPC is hereby approved, and the Mayor is authorized and directed to execute the REPC, attached hereto as Exhibit 1, and any other related document necessary to complete this transaction.

IT IS FURTHER RESOLVED by the Salt Lake County Council that the Mayor and County Clerk are hereby authorized, consistent with the terms of the REPC to execute the Deed and the Easement attached to the REPC and to deliver the fully executed documents to the Salt Lake County Real Estate Section for delivery to UDOT upon payment of the agreed upon purchase amount.
