Mr. Jevon Gibb, Director, Economic Development, Office of Regional Development, led the Pledge of Allegiance to the Flag of the United States of America.

2. CITIZEN PUBLIC INPUT

Mr. Amid Ahmadzadeh stated he was assaulted last week at the Courthouse because he was filming in the lobby, which is not prohibited, and because he was visibly from the middle east. A sergeant from the Sheriff's Office pushed him down and the assault was taped. He asked for medical help and was refused, so he called the Salt Lake City Police Department himself. They sent two officers and an ambulance. The police called him an expletive and would not help him. He has tried to call Sheriff Rosie Rivera, but she has been unresponsive.

Council Member Stringham asked Mr. Ahmadzadeh to fill out a complaint form documenting what happened so there can be an investigation. A member of the Sheriff's Office provided the form.

Mr. Mark Lewon stated he was still unhappy with the staffing of lifeguards at his local recreation center. He had tried to communicate with the Parks and Recreation Department directly, but they have not responded. He had also spoken with Martin Jensen. He felt the County requires more on-duty lifeguards than are necessary for early morning hours, and he did not want to have to go to another pool to swim.

Mr. Jeff Barron stated Utah Code §72-7-503 specifically outlaws the placement of

advertisements in public areas along State highways without permission from the Utah Department of Transportation (UDOT) or along County roads without permission from the County. Violation of this law is a Class B misdemeanor. However, when Mr. Barron recently told Council Member Snelgrove he ought to stop placing his signs in unauthorized areas, his response was: "They're great. I love them. I want more of them." Mr. Barron stated it is important for a body that creates laws to lead by example.
